(Two Years, Full Time, 72 Credits)

M.A. Development

(Two Years, Full Time, 72 Credits)

The programme seeks to prepare individuals capable of informed and thoughtful development action.

Career opportunities: Roles such as Programme Associates/Managers, Researchers and other exciting profiles in organisations working in the domains of livelihoods, sustainability, public health, social entrepreneurship, etc.

M.A. Public Policy and Governance

(Two Years, Full Time, 72 Credits)

The programme equips its graduates with knowledge and competencies required to think deeply and act purposefully in challenging situations of solving governance problems.

Career opportunities: Roles in programme evaluation, research, policy analysis, programme management, advocacy and other aspects of programme operations and governance.

LL.M. In Law and Development

A unique programme designed to impart interdisciplinary and critical approaches to understanding the domains of law, society, and development in India. Our LL.M. places equal emphasis on conceptual, doctrinal and empirical

skills, integrating them in Public and Private law subjects. The interdisciplinary and critical approaches of the programme facilitate meaningful inquiries into ideas that are grounded, informed and socially relevant.

M.A. Economics

(Two Years, Full Time, 72 Credits)

The programme (with specialisation in Development and Policy) is uniquely designed to develop the next generation of economists with the theoretical knowledge and technical skills to perform high-quality analysis grounded in the institutional, developmental and ecological context of contemporary India.
